

# Academic Achievement (Current Student) Master's Scholarship July 2024

Section	Description
Summary	<p>All current University of Phoenix degree students who are actively enrolled in a University of Phoenix master's degree program who (i) have taken a minimum of 9 credits at the University of Phoenix and have at least 9 credits remaining in a University of Phoenix master's degree program; (ii) have an aggregate GPA of 3.85 or higher (on a 4.0 scale) in their current master's degree program; (iii) have not had an unapproved break in attendance greater than 14 days in the last 365 days except for an approved leave of absence as of the scholarship deadline; and apply for this Academic Achievement Master's Scholarship (Current Students) – July 2024 ("Scholarship") prior to the deadline and post attendance in a class between July 1<sup>st</sup>, 2024 and July 31<sup>st</sup>, 2024 ("Initial Attendance Window") will have the opportunity to be considered for one of 15 scholarships worth up to a maximum of \$2,000 each, distributed over 11 courses.</p> <p>NOTE: Students must begin the admissions application prior to completing this scholarship application.</p>
Application Deadline	<p>The Scholarship application will be made available online on July 1<sup>st</sup>, 2024. Applications must be completed and submitted online at <a href="http://www.phoenix.edu">www.phoenix.edu</a> by 11:59pm MST July 31<sup>st</sup>, 2024 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.</p>
Eligibility Criteria	<ol style="list-style-type: none"> <li>1. Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Citizen Immigration Services and verified through CIS Form g-845; or have been granted asylum along with the approved Notice of Action issued by the Citizen Immigration Services.</li> </ol>

Selection Process	<ul style="list-style-type: none"> <li>a. As part of the scholarship application, the University of Phoenix will review the applicant's official University of Phoenix student account and transcripts to verify the following requirements:               <ul style="list-style-type: none"> <li>i. Applicant has completed a minimum of 9 credits at the University of Phoenix and has at least 9 credits remaining in their University of Phoenix master's degree program as of the Scholarship application deadline.</li> <li>ii. Applicant has not had an unapproved attendance break of greater than 14 days in the last 365 days as of the Scholarship application deadline.</li> <li>iii. Applicant has a minimum GPA of 3.85 (on a 4.0 scale) as of the Scholarship application deadline</li> </ul> </li> <li>6. Applicant must be actively enrolled and attending the University of Phoenix for a master's degree program within the Initial Attendance Window.</li> </ul>

It is the applicant's responsibility to submit a complete and signed application along with any required and supporting documentation, which must be received on or before the Application Deadline. Maintenance Requirements	<p>In order to continue disbursement of the scholarship award, applicant must meet the following maintenance requirements:</p> <ol style="list-style-type: none"> <li>1. Applicant must remain in a master's program (all coursework attended must be program applicable courses). Awards will only be applied to courses taken as part of their bachelor's or master's program, specific to the original program level award.</li> <li>2. Applicant must successfully pass each course attempted in accordance with their program's requirements as outlined in the academic catalog for all courses. Any withdrawals or courses not successfully passed in accordance with the program requirements will terminate the scholarship.</li> <li>3. Applicant may not have an unapproved attendance gap greater than 35 days.</li> </ol>

Terms and Conditions

By applying for a University of Phoenix scholarship and/or accepting the scholarship award, the applicant and/or recipient agrees to the following terms and conditions. Failure to abide by any of the following terms and conditions shall result in either disqualification of the scholarship award or termination of the scholarship award.
