

Summary	All new University of Phoenix Associate degree alumni students who (i) apply for and enroll in a University of Phoenix bachelor's degree program; (ii) have an aggregate GPA of 3.0 or higher (on a 4.0 scale) in their University of Phoenix associate's degree; and (iii) apply for this Forever a Phoenix® Bachelor's Scholarship – February 2024 ("Scholarship") prior to the deadline and register and post attendance in their first class between February 1 st , 2024 and February 29 th , 2024 ("Initial Attendance Window") will have the opportunity to be considered for one of twenty-five (25) scholarships worth up to a maximum of \$2,000 each.

	<p>a. As part of the scholarship application, the University of Phoenix must receive official transcripts. Transcript/s must verify the following requirements:</p> <ul style="list-style-type: none"> i. Applicant has an associate degree from University of Phoenix ii. Applicant had a minimum GPA of 3.0 iii. Official transcripts must be received, and the applicant must be officially evaluated and fully admitted into the University of Phoenix by the last date of their first registered course. <p>Applicant must post attendance to their first bachelor's degree course within the Initial Attendance Window.</p>
<p>Selection Process</p>	<ol style="list-style-type: none"> 1. The recipients of the scholarships will be selected by the University of Phoenix. 2. It is the applicant's responsibility to submit a complete and signed application along with any required and supporting documentation, which must be received on or before the Application Deadline. The University of Phoenix accepts no responsibility for incomplete applications, applications not in proper form, lost applications, or any other submission in exception to the instructions. 3. Scholarship selection shall be made without regard to race, color, religion, sex, sexual orientation, gender identity, age, national origin, disability, veteran status, or any other category protected by federal, state, or local law. 4. The 25 scholarships will be awarded to the eligible applicants with the highest GPA that apply by the application deadline. Starting on March 1st, 2024, the University of Phoenix will begin the selection process for eligible qualified students. 7. Recipients will be notified no later than April 1st, 2024.
<p>Scholarship Award Distribution and Timing</p>	<p>The University of Phoenix will determine and notify the recipients of the scholarships upon validation.</p> <ol style="list-style-type: none"> 1. The maximum scholarship award is \$2,000. The Scholarship shall be disbursed as a credit toward the student's tuition payments at a rate of \$100 per course beginning with the student's first attended course and thereafter for those continuously attended courses in their bachelor's

2. Scholarship award is a non-cash award to recipient's University of Phoenix account as outlined on the scholarship application.
