Scholarship Award Distribution and Timing	<p>The University of Phoenix will determine and notify the recipients of the scholarships upon validation.</p> <ol style="list-style-type: none"> 1. The maximum Scholarship award is \$1,000. The Scholarship shall be disbursed as a credit toward the student's tuition payments at a rate of \$91 per course beginning with the student's first attended course and thereafter for those continuously attended courses in their master's program until: (i) the student completes 10 courses, after which a final disbursement of \$90 will be applied toward the eleventh course, thus maximizing the \$1,000 total Scholarship amount, or (ii) two years has elapsed from the student's first date of attendance in the their first course, or (iii) the student graduates from their program, whichever comes first. Subsections (i)-(iii) are collectively hereinafter referred to as "Terminating Events". 2. Only the applicants selected as Scholarship recipients will be notified by the University of Phoenix.

Maintenance Requirements

In order to continue disbursement of the scholarship award, applicant must meet the following maintenance requirements:

1. Applicant must remain in a master's program (all coursework attended must be program applicable courses). Awards will only be applied to courses taken as part of their master's program, specific to the original program level award.
